ORDERS AT PARTIAL TRIAL

Date: July 31, 2023

16 A partial one day trial was held in Department #79 on July 31, 2023. The following  
17 orders which are to become part of the parties final judgment were made:

18  
19 1. Date of Separation: The Court finds the parties' date of separation is September 15,  
20 2022 when Respondent, Hanna Mars, served her temporary restraining order on Petitioner and they  
21 began living separate and apart.

22 2. Child Custody: The Court reserves the issue of final child custody orders for the  
23 second half day trial.

24 3. Permanent Spousal Support: The Court reserves the issue of permanent spousal  
25 support for the second half day trial.

26 4. Child Support/ Child Support and Temporary Spousal Support Arrears: The Santa  
27

1 Clara County Department of Child Support began enforcing the support issues in this matter on  
2 July 221, 2023 and those issues are no longer before the family court. The Court sets a hearing  
3 on those support issues in Department number 71 on September 5, 2023 at 9:01 a.m.

4 4. Furniture and Furnishings: Each party is awarded as his or her separate property those  
5 items of furniture, furnishing, and personal belongings currently in his or her possession without  
6 offset.

7 5. Vehicles: Respondent, Hanna Mars is awarded as her separate property the 2014 VW  
8 Tiguan without offset. Petitioner, Kostiantyn Mars is awarded as his separate property the 2022  
9 Hyundai Tucson without offset. Respondent will cooperate with Petitioner to take Petitioner's  
10 name off the title to the VW Tiguan. Petitioner will be responsible for providing all required  
11 documents to the DMV.

12 6. Robinhood Stock Account: Petitioner is to transfer one-half the value of the  
13 Robinhood stock account as of the date of separation to Respondent within 30 days of July 31,  
14 2023.

15 7. EPAM Retirement 401(k): The court orders the parties to mutually agree upon an  
16 expert to draft the QDRO necessary to dividing the 401(k) account according to the time rule.  
17 The parties are ordered to meet and confer re name of an expert and select a name within five (5)  
18 days of July 31, 2023. If no agreement, the parties may submit via email to Department #79 the  
19 names of three QDRO experts and the Court shall appoint the expert to draft the QDRO. The  
20 parties shall each pay one-half of the cost to the expert drafting the QDRO.

21 8. 2014 Peugeot: The court confirms the 2014 Peugeot located in Ukraine to Respondent  
22 as her separate property.

23 9. EPAM Stock: Petitioner will provide EPAM stock information to Respondent's  
24 attorney within 30 days of July 31, 2023 showing all stock awarded to him from the date of  
25 marriage until the date of production. The court reserves jurisdiction over the division of EPAM  
26 stock earned by Petitioner during the marriage.

27 10. Division of Credit Card Debt and Bank Account Balances: The Court reserves the  
28 issue of the division of the community bank account balances and credit card debt for the second

1 half day trial. Petitioner is ordered to speak to attorney Nancy L. Roberts immediately after this  
2 hearing regarding the credit card debt and financial account balances/division.

3 11. Attorney's Fees Request: The Court reserves the issue of both Petitioner's and  
4 Respondent's requests for attorneys fees and costs.

5 12. Trial Date: The second half-day trial is set in Department #79 on September 28, 2023  
6 at 9:00 a.m. on the issues of permanent spousal support, child custody, bank/financial accounts  
7 and marital status.
