### MINUTE ORDER

Father to provide three names of possible screeners to Mother. Mother may delete one name; Father to choose from two remaining names.

What is the legal basis for this order?

Pending hearing, Father may have professionally supervised visitation as follows:

Three times per week for up to two hours per visit. A weekend visit may be part of the three visits.

Father alone is to select the supervisor.

The Court finds that Father's timeshare is 3%.

What is the legal basis for this order?

The Court orders mutual Smith-Ostler orders.

The Court denies the request for a seek work order at this time.

Ms. Roberts is directed to update the Dissomaster based upon the modifications the Court made and file with DV.

Gnyda Hanna Nahorna is working. What is the legal basis for this order?

The guideline child support amount is ordered and effective 10-6-22. If Petitioner has paid rent for October, any amount he has paid will offset any arrrears that he owes.

The Court now vacates the order under #11 of the DVRO requireing Petitioner to pay the rent each month. Respondent is now responsible for paying the rent effective November 1st.

The Court grants guideline spousal support at this time.

The order under #14 remains in place.

The order under #18 of the DVRO request is vacated.

Extortion of money in favor of kidnapper and murderer

The Court orders that Petitioner continue to pay all debts listed. In light of these payments, the Court denies the request for attorney fees at this time, finding that Petitioner does not have the ability to pay.

The parties are ordered to meet and confer to facilitate the retrieval of Petitioner's and Petitioner's Grandmonther's personal items within one week.
